SPECIAL BOARD MEETING

August 8, 2023

The Board of Trustees of School District No. 414, Twin Falls County, State of Idaho, met in its properly posted location in the district board room located at 141 Center Street West, Kimberly Idaho on Tuesday, August 8, 2023.
