


**Jerome School District will:**

1. Provide the educational facility.
2. Provide a teacher.
3. Provide all curriculum and learning materials.
4. Collect progress-monitoring data toward IEP goals.
5. School psychologist assessments may be provided, but Kimberly School District will be charged the going Medicaid rate for each assessment.
6. Provide all academic assessments needed for special education purposes.
7. Work collaboratively with the Kimberly School District to provide all needed information so Kimberly School District can write all eligibility and IEP reports.
8. Jerome staff will part be of the IEP team process and attend the meetings.
9. Give the Kimberly School District one weeks' notice should the program become full, and we no longer have the capacity for out of district students. In which case the Kimberly School District will need to make other arrangements for placement.
10. Bill the Kimberly School District monthly at a daily rate of \$75 for each day a student is enrolled in the Jerome Academy program. This includes billing for days the student is not in attendance.

**Kimberly School District will:**

1. Reimburse the Jerome School District, monthly, at a rate of \$75 per day that the student is enrolled in the Jerome Academy Program. This includes days the student is not in attendance.
2. Provide transportation to and from the Jerome Academy. \*Kimberly will pay Jerome Academy the Mileage for use of their van.
3. Provide any related services that the IEP determines necessary.
4. Provide any assistive technology devices that the IEP determines is necessary.
5. Will be responsible for all special education timelines, and required paperwork.
6. Responsible for all Medicaid billing and collecting required information.

# AGREEMENT

2021-2022 School Year

**Service Provider:** Day Treatment Youth Services, LLC

**Contracting School/Agency: Kimberly School District**

We operate a behavior modification/education program for **Emotionally Impaired** and/or **behavior disordered** students. Through this agreement, we are offering to sell “placements” in this program to surrounding school districts and agencies because of limited enrollment, all placement requests may not be accommodated. Consequently, placements will be sold on a “previously-served” and then a “first come-first served” basis.

Both parties to this agreement understand that students and families participating in the **Day Treatment Youth Services** program will be subject to the policies and rules of that program. If the student and/or family fail to comply or demonstrate non-cooperation, then the student will exit the program and be referred back to the district/agency of origin.

The above contracting school/agency understands that, while the student is enrolled in Jerome Academy/Day Treatment, the **Jerome School District #261** will be due all ADA and Special Education funding for that student. **DTYS** will bill the Kimberly School District for all school-based Medicaid PSR services provided for the school year 2021-2022.

**\*Note: Every referral will be evaluated by Day Treatment Youth Services/Jerome School District personnel to determine appropriateness of placement in the program. Certain students may not be accepted or appropriate for the program.**

Day Treatment Youth Services will:

- 1. Accept school district students through the use of a “placement” mentioned below or through Medicaid eligibility and will provide behavior management services to these students during the 2021-2022 scheduled school year.**
- 2. Sell each “placement to the above identified contracting school district/agency for the amount of \$5500.00 per school year.**
- 3. Reimburse the Jerome School District for any and all Medicaid recoupment including civil penalties incurred, for any student that came from outside the Jerome School District boundaries regardless of the reason.**
- 4. Medicaid reimbursement will be billed though the students IEP at a rate of 32.00 per hour of individual or 8.00 per hour group.**
- 5. Day Treatment Youth Services will submit all appropriate paperwork for reimbursement no later than 5 business days after the first day of each month, the contracting school district will issue reimbursement by the end of said month.**

School District/Agency will:

**1. Pay for the cost of:**

a. **Non-Medicaid placements (at the cost of \$6000.00 or \$5500.00 if paid by September 01 2021.**

B **.Transportation of students to and from Day Treatment Youth Services or Reimburse Day Treatment Youth Services for transport costs at the rate of .60 per mile mileage will be figured from the facility to students home and back to the facility am/pm**

**Any necessary support services/special education services i.e. Speech Therapy, OT, etc.**

**2. Maintain frequent contact with student(s) by attending regularly scheduled Student Progress conferences and/or other meetings where the student(s) progress and continuation are discussed.**

**Request: The above mentioned school district/agency is requesting to purchase 1 placement(s) in the Day Treatment Youth Services Program. Each placement costs \$5500.00.**
